



## The Seyon Group and BentallGreenOak partner to acquire 7-asset industrial portfolio in Greater Boston

Boston (March 23, 2021) - The Seyon Group ("Seyon"), in partnership with BentallGreenOak ("BGO"), announced that it has acquired 300 Foxborough Boulevard, 35-41 Hampden Road, 21 Oxford Road, 515 West Street, and 375, 105, and 110 Forbes Boulevard in Mansfield, MA (together, "Mansfield Research Portfolio"). This seven-building light industrial/R&D portfolio is located within the Cabot Business Park ("CBP") in Greater Boston's 495 South market. The 495 South market is traditionally the strongest-performing industrial market in New England due to its proximity to major population centers in Boston, Providence, and Worcester. CBP is one of the four established institutional industrial business parks in Greater Boston, and is strategically located at the intersection of the I-495 beltway and I-95 highway. This transaction marks the first joint venture acquisition for Seyon and BGO in Greater Boston.

Mansfield Research Portfolio features a total of 248,969 square feet and is currently 82% leased to six tenants. The Portfolio's physical specs include 12-21 'ceiling heights, 18 loading docks, and 1,129 parking spaces.

"The Mansfield Research Portfolio provides a one-of-a-kind opportunity to acquire seven highly functional, Class A, light industrial assets in a premier location," shared Bryan Blake, Managing Partner at Seyon. "We are beyond thrilled to partner with BGO on this transaction."
